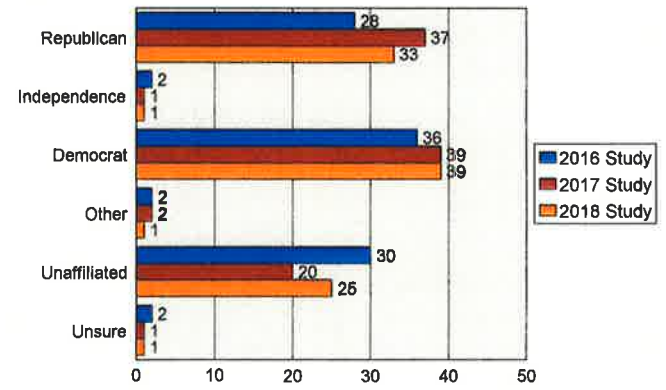

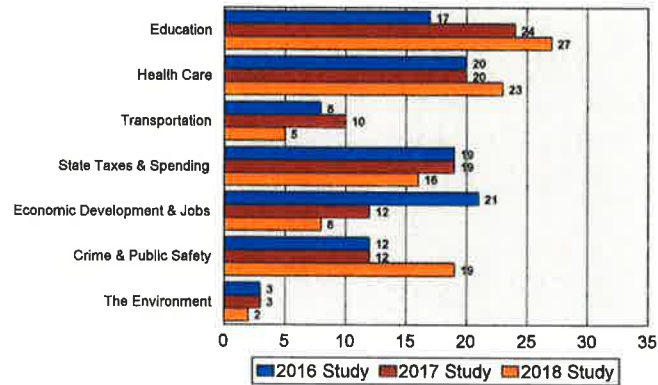

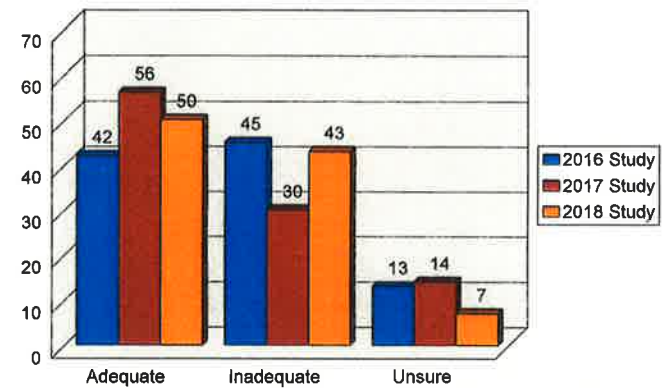

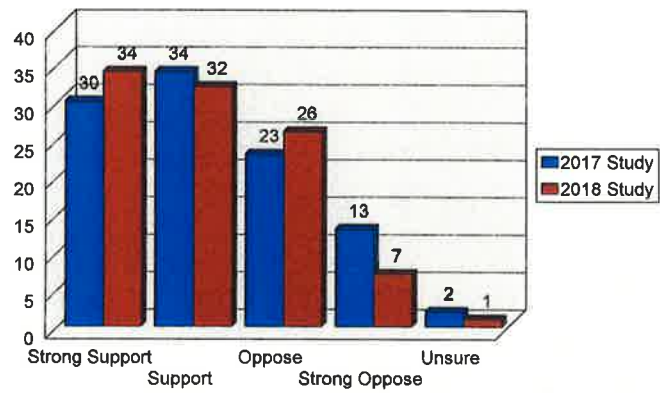

Mandatory Inflation Increase in Education Funding Formula

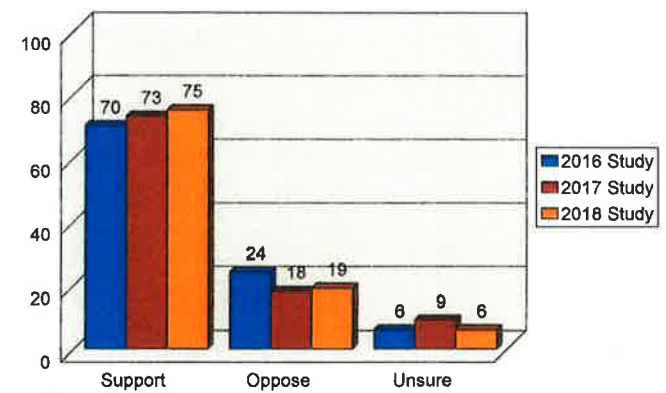

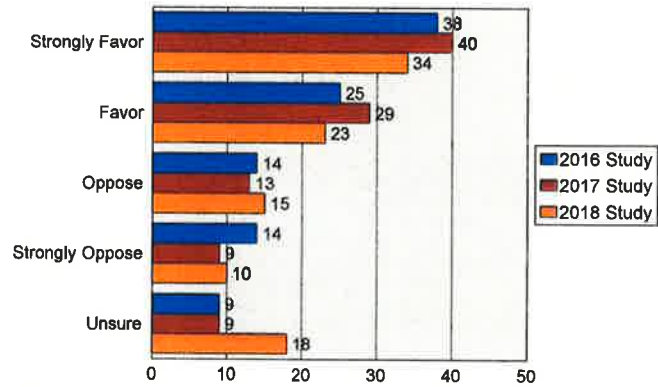
Factor Regional Cost-of-Living into Funding Formula

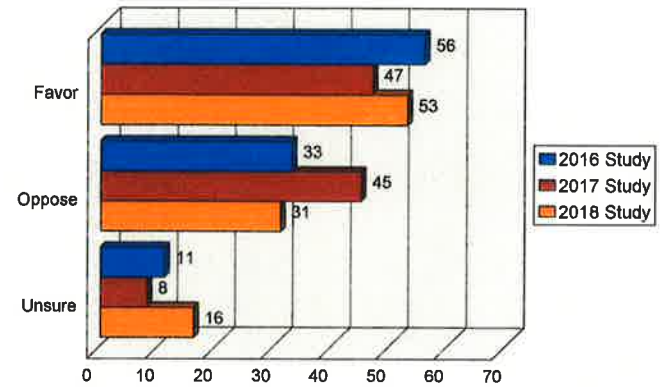

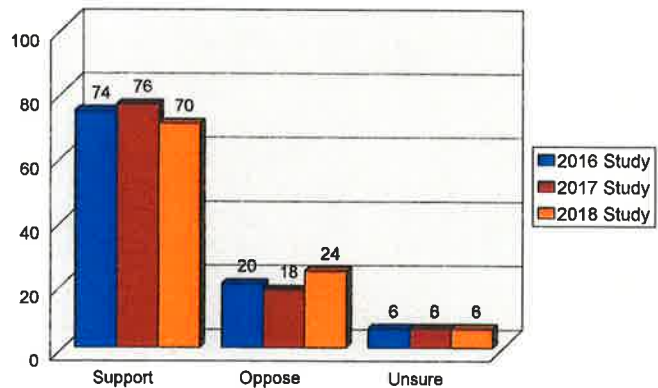

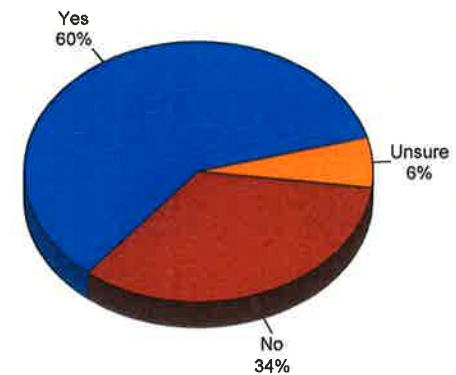

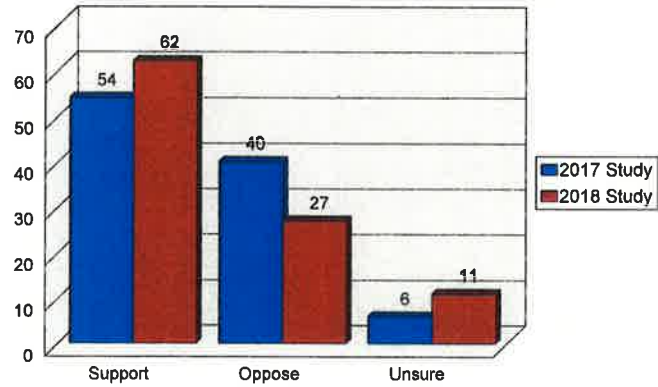

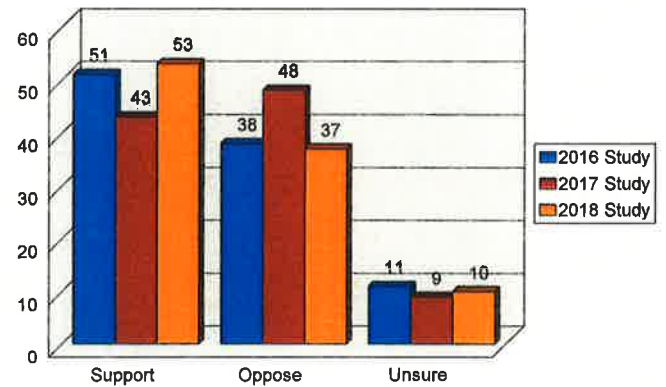

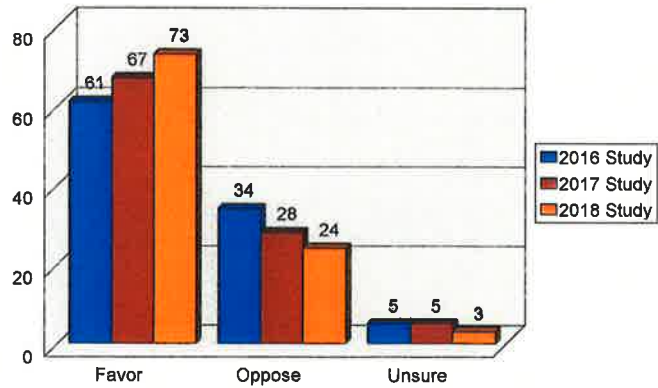

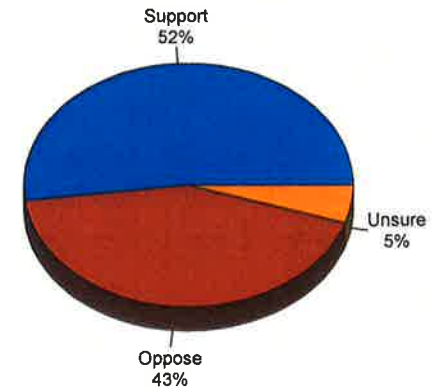

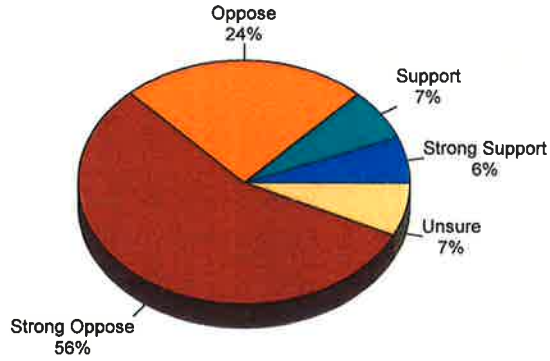

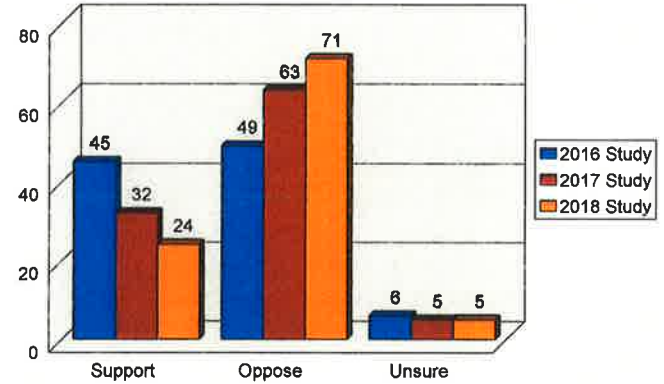

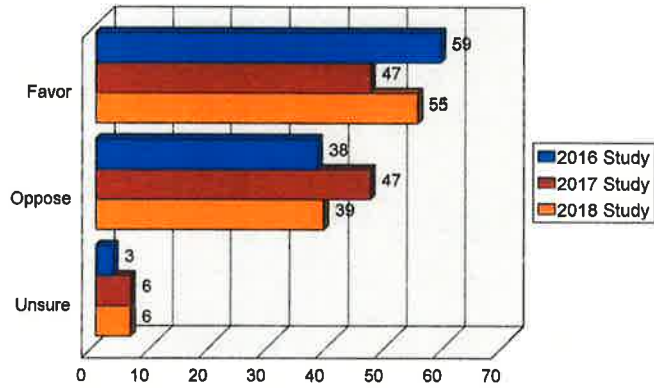

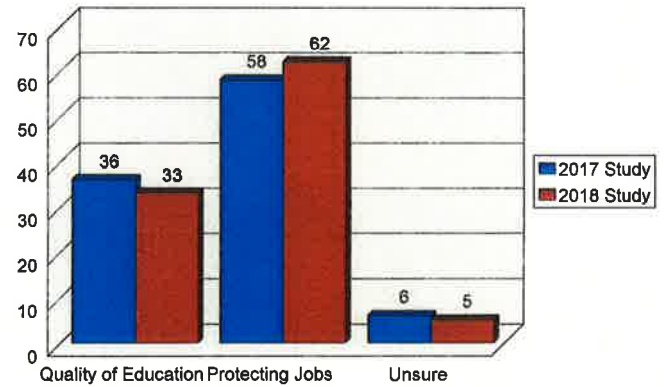

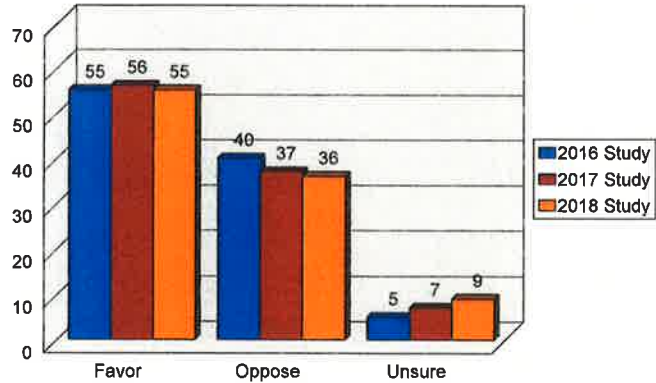

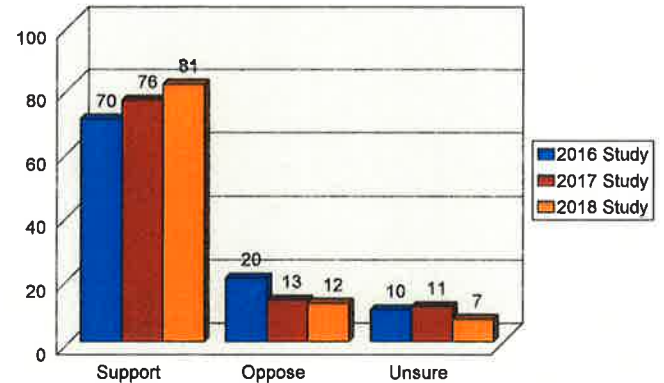

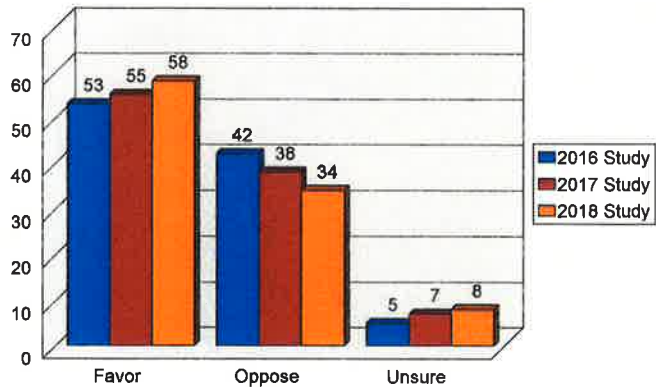

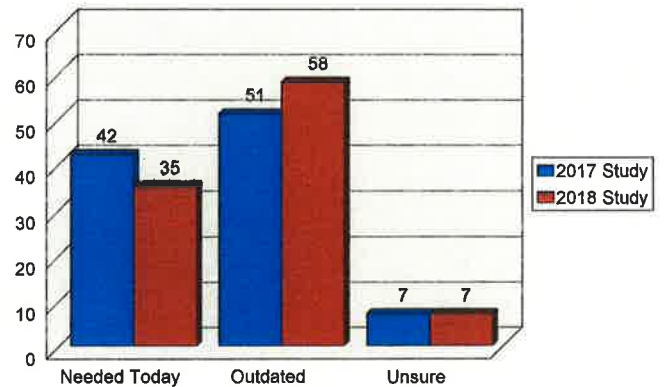

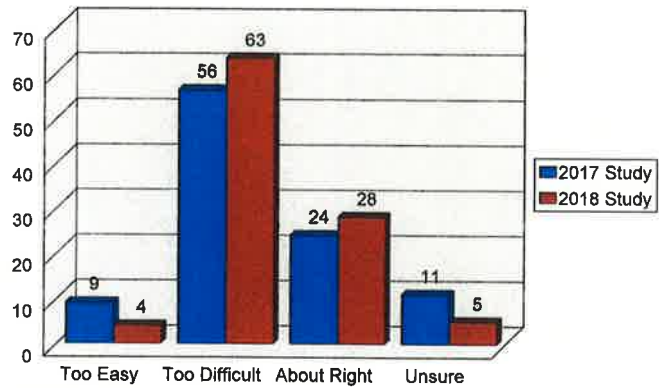

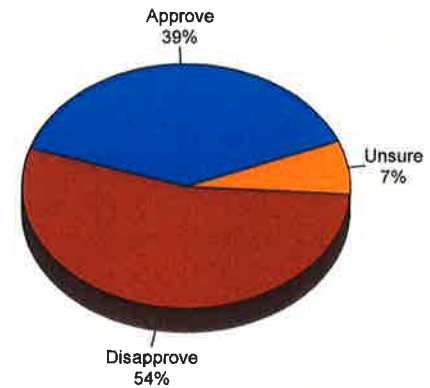

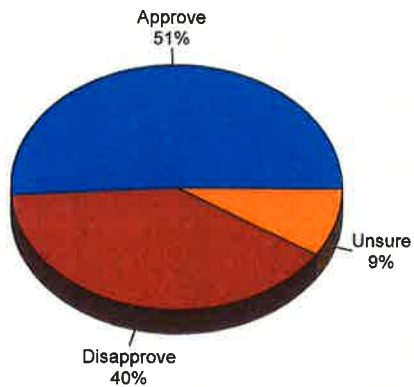

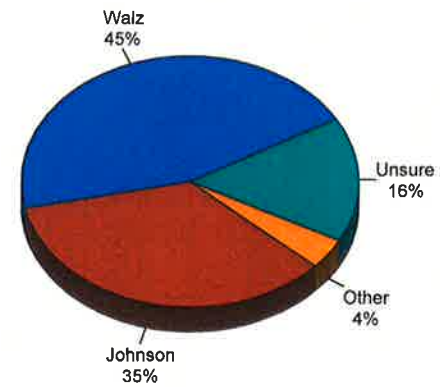

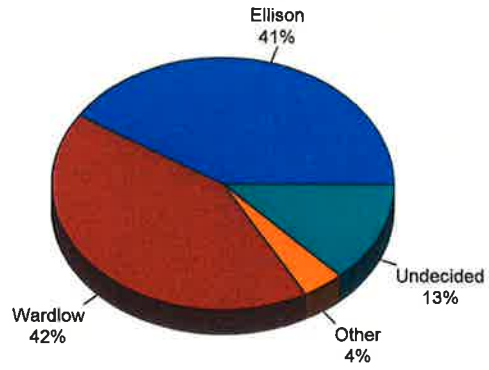
